- Data will be accessed and edited by Aberdeenshire Council staff and therefore, Aberdeenshire Council is the Data Controller.

## The retention period for the data is:

- to request rectification or erasure of your personal data, as so far as the legislation permits.

When you sign up to the mailing list, you will be asked to give your consent and to confirm that you have been provided:

	why your information is being collected;
	the purposes for your information being collected;
	full information about the intended processing;
	details of any sharing of your information;
	details of the security for transferring your information to any country outside the EEA;
	the applicable retention period;
	details of any automated decision-making or profiling applied to your information; and
	details of your rights.
